Troublesome procedures for acquiring, changing, and renewing residence status, Please leave it to the Asahibashi Administrative Scrivener Office!

1. Complicated application procedures for residence status

Application procedures for residence status (visa) are difficult if you apply for them yourself.

First of all, there are 28 types of residence status, and you need to thoroughly research whether you can obtain the desired residence status, collect numerous documents from various government agencies and, if necessary, from your employer, and it takes time to prepare explanatory materials



to answer questions from the immigration bureau. This is especially difficult for foreign residents who are not familiar with Japanese to do on their own.

Furthermore, if the immigration bureau rejects your application even once due to incomplete application documents, it will be much more difficult to get permission even if you reapply thereafter.

2. Strengths of our office

Our office will carry out smooth application procedures by thoroughly discussing with the applicant based on the interview sheet, confirming the possibility of obtaining the desired residence status, obtaining application documents, and providing a clear explanation to the immigration bureau.

In addition, our firm's representative has ample experience with filing applications with the Immigration Bureau, and in addition to his license as an administrative scrivener, he is also qualified as an "application intermediary administrative scrivener," meaning he can submit and coordinate application documents to the immigration bureau on behalf of the applicant, allowing for one-stop service without the applicant having to appear at the immigration bureau in person.

3. Procedure fees for various residence statuses

- (1) Visa change (application for permission to change residence status): 55,000 yen (tax included)
- (2) Visa renewal (application for permission to renew residence status): 40,000 yen (tax included)

Note: The main targets are as follows (consultations are also available for others)

- ·Long-term residents
- ·Spouses of Japanese nationals, etc.
- ·Spouses of permanent residents, etc.
- •Engineers, Specialists in Humanities, International Services (Technical Persons)
- ·Skills
- Nursing care
- ·Entertainment

- ·Specified activities
- (3) Specific skills (1, 2): 77,000 yen (when changing, tax included) 55,000 yen (when renewing, tax included)
- (4) Permanent residence permit application: 110,000 yen (tax included) (555) Short-term stay (visiting relatives, short-term business): 35,000 yen (tax included)

- Note 1) There will be a separate application fee of 4,000 yen to the immigration bureau (8,000 yen for permanent residence applications).
- Note 2) If the immigration bureau requests you to submit a statement of reasons and a letter of explanation, it will cost 10,000 yen per A4 sheet. However, this is requested very infrequently.
- Note 3) As I do not speak a foreign language, advance contact will be via email.
- Note 4) An interpreter will be arranged if necessary. However, the fee will be determined separately.

4. Apply for your residence permit as soon as possible

Preparing application documents takes a lot of time because it is necessary to collect various documents and document the results of interviews with the applicant. In addition, even if you submit the application documents to the Immigration Bureau after preparing them, there are some residence



statuses where it takes more than a month or several months to complete the review. It is best to apply early so that your period of stay does not exceed.
